Auction Terms and Conditions

Onsite Registration: Onsite auction registration will begin one hour prior to the beginning of the auction. All bidders are required to register with a valid form of photo ID (driver's license) and acknowledge having read and agree to be bound by the auction terms and conditions.

Online Bidding Registration: All online bidders will be required to first register with <u>www.Proxibid.com</u> and then contact the auction company to fill out the "Online Bidding Registration" form. In addition to the completed form, online bidders are required to wire transfer a <u>(\$5,000) online registration deposit</u>, (non-refundable, if winning bidder) prior to being allowed to place a bid online. Order of Auction: The farms will be offered individually and will not be offered collectively due to the location and type of property. Bidders interested in both farms will need to bid on each farm individually. Farm #1 will be sold first, then Farm #2 will be sold.

Buyer's Premium: A Seven percent (7%) buyer's premium shall be added to the winning bids at the auction to arrive at the total contract price to be paid by the successful bidder(s). The internet buyer's premium for anyone who elects to bid online via Proxibid, shall be Seven percent (7%) and will be applied to the high bid placed online, as stated above. The winning bid plus the buyer's premium shall be the total contract price to be paid by the successful online bidder.

Down Payment and Contract Signing: The successful bidder(s) shall be required to place 10% of the total contract price in escrow and sign the purchase agreements, immediately following the conclusion of the auction. Seller shall retain all CRP payments due and payable for the contract year ending September 30, 2013 and all prior payments. Buyer shall be entitled to the payment for the current contract year ending September 30, 2014 and any future payments.

Mineral Rights: Fifty percent (50%) of the seller's mineral rights will be transfer with the surface and shall be conveyed to the buyer at closing.

Survey: Both farms are legally described and the seller shall not provide a survey. If the buyer desires a survey, it shall be at the buyer's sole expense.

Taxes: The 2014 ad valorem taxes shall be prorated to the date of closing. Any previous or outstanding tax liens to include but not limited to (federal tax liens, state tax liens) shall be paid in full from the proceeds of the sale.
